


Participants





Participants – Geographical Reach



• 35 charities participated in the latest survey with almost 2/3 being National charities.





Participants – Charity Size




• More than half of the charities have a workforce with more than 100 employees.





Participants – Primary Sector




• As with previous surveys, Health is still the top Primary Sector for responders to the survey.





Participants – Donors




- The total donor base for the latest Survey participants is almost 10 million with 1.2 million identified as Active.

Participants – Donor Trend




• The number of Active Donors as a percentage of the whole donor pool has been slowly decreasing over the last 3 surveys.

- Whilst the percentage of Active donors within the whole donor pool is decreasing (see previous slide) the actual number of Active donors is steadily increasing.
- The average number of Active donors across all 3 surveys for 2017 is 44,413.



Fundraising Income – Overall and Bequest




- There is a drop in overall income between 2014 and 2015, due to the decrease in the number of participants.
- Total Fundraising income for 2017 participants was reported at \$637.17m.

Fundraising Income – Overall and Bequest




- Of those participants who responded to all 5 surveys, the change is quite small.

Fundraising Income – Overall Income




- Of those participants who responded to all 5 surveys, the change is quite small.

Fundraising Income – Average Income




- One third of the participants have responded to the last 5 surveys.

Fundraising Income – Average Income Trend




• Of those participants who responded for all 5 surveys, the average Bequest Income has been increasing.

Fundraising Income – Bequest Income by Type




- Where Bequest Type was not supplied, the Income was allocated to Unknown.

Fundraising Income – Average Total Bequest Income




- Where the participants specified the type of Bequest received in the survey, the average total of that income across all participants (total income not the average value of the Bequest itself).
- The Total Average Bequest Income across all survey participants is \$3.7m.





Fundraising Income – Average Bequest Value



- Where specified, the Average Residual Bequest value is more than 3 times higher per payment than Pecuniary or Perpetual Trusts.
- Although charities are on average receiving more Perpetual Trusts, the average value of each Trust is significantly lower.
- The overall Average Bequest gift is \$59,812 across the 3 Bequest types.





Bequest Detail – Death Notification Types




- Fairly even split between Residuals and Pecuniary Notifications.
- The average number of notifications for respondents was 12.





Bequest Detail – whether known to Charity




• Just under half of the Bequests realised in 2017 were from known donors (although it was not known there was a gift in their will), a quarter were from gifts known in advance of the notification and the remainder were not known in advance.

Bequest Detail – Bequestor Gender




• Just under half of the Bequestors are Female.





Bequest Detail – Confirmed Bequestor by Gender




- The Survey Respondents who are anonymised in this chart.

Bequest Detail – Confirmed Bequestor




• Of the 34 respondents, the total Confirmed Bequestor count is 22,381 with an average of 658 per participant.





Bequest Detail – Confirmed Bequestor Trend




• The average number of Confirmed Bequestors has been slowly increasing over the last 5 surveys.





Bequest Detail – Confirmed-to-Realised Ratio



- These ratios differ greatly between the Survey Respondents (who are anonymised in this chart).
- The ratio is defined as the number of Confirmed Bequestors divided by the number of realised Bequests in that survey.
- The Confirmed-to-Realised Ratio across all respondents is 24.07





Bequest Activities – Program Summary




- Of the 35 Responders, 5 charities do not have an active Bequest Program.
- The most common Bequest activity amongst the responders was to send out Donor Surveys, this was followed by Direct Mail and a Bequest Club.





Bequest Activities – Program Summary Trend




• For all Charities across all 5 surveys, Donor Surveys and Direct Mail are still the most common Bequest Activity.





Bequest Activities – Program Development



- Of all responders 63% have a Dedicated Bequest Team/Person, thus have on average a higher number of Confirmed Bequestors.
- For those who did not have a Dedicated Bequest Team/Person they described themselves as having a young bequest program with little bequest activities in place or did not elaborate.
