What type of gift is best?

A gift as an 'endowment' provides for the capital amount of the gift to be invested, and only the income generated from the investment may be utilised for the Institute's purposes.

A planned gift is also known as a bequest

Your solicitor will most likely call your planned gift a bequest.

A specific bequest names the Bionics Institute as a beneficiary for a specified dollar amount, or a specified percentage of the estate.

A residual bequest names the Bionics Institute as a beneficiary of the remainder of an estate after all debts, expenses and other beneficiaries have been paid.

A contingent bequest is one which only operates in favour of the Bionics Institute as an alternative beneficiary if other named beneficiaries of the estate do not survive the person making the will.
